The Opportunity

The College of Agriculture and Life Sciences at NC State University invites applications for the position of Associate Dean and Director, NC State Extension.

The Position

The Associate Dean and Director of NC State Extension provides strategic leadership for all aspects of the university's Extension portfolio and reports directly to the Dean of CALS. As a key member of the Dean's administrative team, the Associate Dean of Extension works alongside the Senior Associate Dean of Administration, the Associate Dean of Academic Programs, and the Associate Dean and Director of the North Carolina Agricultural Research Service.

In this role, the Associate Dean and Director leads NC State Extension at the state, regional, national, and international levels. NC State Extension encompasses faculty and staff from CALS, the College of Design, the College of Natural Resources, and the College of Veterinary Medicine. The position collaborates closely with the deans, directors, and heads of 12 academic departments to deliver research-driven solutions, educational programs, and training that improve the quality of life, economic prosperity, and environmental health of all North Carolina communities.

With operations spanning all 100 counties and the Eastern Band of Cherokee, NC State Extension thrives through strong partnerships with local governments, which provide essential funding, space, and support. As the leader of these efforts, the Associate Dean and Director will guide these collaborations, ensuring mutually beneficial outcomes while empowering Extension experts to serve as primary educators. Together, they will address critical challenges and drive meaningful, lasting community impact.

The Associate Dean and Director may also receive a secondary appointment as the NC State University Vice Provost for Outreach and Engagement, reporting to the Executive Vice Chancellor and Provost. In this capacity, the incumbent advances NC State's mission of making knowledge and resources accessible to the public, in alignment with the university's strategic plan, Wolfpack 2030: Powering the Extraordinary. The Vice Provost collaborates with community partners to expand teaching, research, and public service, reinforcing NC State's commitment to its 21st-century land-grant mission. This dual role amplifies the impact of NC State Extension, extending its reach beyond agricultural life sciences and beyond state boundaries.

Qualifications

The successful candidate must have a terminal degree (Ph.D., J.D., or Ed.D.) in their area of expertise and meet the criteria for tenure as a full professor in one of CALS' 12 academic departments.

Candidates must demonstrate a strong understanding of the land-grant university philosophy and the mission of NC State Extension to translate research into actionable solutions that improve lives. They should possess experience in addressing critical needs in agriculture, food, health and nutrition, and youth development, while fostering collaboration with public and private entities.

Visionary leadership is essential, with the ability to position NC State Extension and the Office of Outreach and Engagement as pivotal contributors to North Carolina's progress. The candidate must also recognize the vital role of local government partnerships that fund and support field faculty and staff across the state.

The ideal candidate will be expected to demonstrate success, enthusiasm, and capacity for:

- **Leadership** Unite diverse teams and stakeholders across the state to maximize the impact of Extension programs, cultivating a culture of collaboration and innovation.
- **Vision** Articulate and implement a compelling vision for NC State Extension, aligning its current strategic plan with evolving challenges and opportunities across North Carolina.
- Success Drive measurable outcomes that empower Extension clients to achieve their goals, while fostering
 resilience, adaptability, and long-term growth in communities.
- **Communication** Engage effectively with internal teams, external stakeholders, and community partners to elevate Extension's visibility and value, using creative strategies to share its successes and opportunities.
- **Fiscal Responsibility** Manage budgets and resources with transparency and integrity, ensuring alignment with institutional priorities while advocating for investments in impactful programs.
- Fundraising Collaborate with CALS Advancement to define and champion fundraising priorities, building relationships with donors, and cultivating partnerships that enhance Extension's reach and capacity.
- Management Promote a high-functioning organization through proactive planning, accountability, clear communication, and a commitment to continuous improvement and adaptability.

Preferred Qualifications

The ideal candidate will demonstrate:

- A proven ability to engage, inspire, and lead diverse teams effectively.
- A commitment to delivering innovative services, resources, and technologies that drive client success.
- Strong skills in listening, building relationships, and uniting stakeholders around common goals.
- Expertise in networking, negotiation, strategic thinking, and critical decision-making.
- A talent for promoting Extension's successes to expand public awareness, support, and involvement.
- Experience in designing, implementing, evaluating, and ensuring accountability for impactful programs.
- Proficiency in managing budgets with integrity, transparency, and fiscal responsibility.
- A track record of collaborating with administrators across disciplines and institutions.
- Visionary leadership that advances Extension's role locally, nationally, and globally, while fostering interdisciplinary engagement.
- A deep understanding of and passion for advocating for North Carolina agriculture.


